Sheikh Hasina demands 'justice'

Dhaka/New Delhi

Bangladesh's deposed prime minister Sheikh Hasina on Tuesday demanded "justice", saying those involved in recent "terror acts", killings and vandalism must be investigated, identified and punished.

In her first public statement after her ouster on August 5, 76-year-old Hasina said several lives have been lost in violence in the name of agitation since July. "I express grief at the deaths of students, teachers, police personnel, pregnant women, journalists, cultural activists, working people, leaders and workers of the Awami League," said Hasina.

A Liberian-flagged oil tanker in the Red Sea came under attack three times on Tuesday, including in an assault using a bomb-carrying drone boat, likely the latest in a campaign by Yemen's Houthi rebels over the Israel-Hamas war, officials said.

The attacks come as the rebels' main sponsor, Iran, weighs possible retaliation against Israel over the assassination of Hamas official Ismail Haniyeh last month in Tehran, Iran's capital, which has renewed fears of a wider regional war in the Middle East.
